# **Economy**

## Economy

- In August, public sector net borrowing excluding temporary effects of financial interventions (PSNB ex) was £10.5 billion, according to the <u>ONS</u>. This was £0.9 billion lower than in August 2015, when it was £11.5 billion. Public sector net debt (PSND ex) was £1,621.5 billion in August 2016, equivalent to 83.6% of GDP. This compares to £1,569.5 billion, or 83.6% of GDP, 12 months earlier.
- According to the CBI's <u>Industrial Trends Survey</u> for the three months to September, 11% of firms, on balance, reported an increase in output volumes. Looking to the next three months, a balance of 22% of firms expects output volumes to grow. The CBI also reported that export order books remained well above their long-run average, despite weakening slightly, which is largely owing to the recent Sterling depreciation.

#### Housing

- The <u>Council of Mortgage Lenders</u> reported that total gross mortgage lending in August reached £22.5 billion. This was 6.8% higher than in July 2016 and 15.1% higher than a year earlier. The CML reported that the latest figures reflected a recovery in market sentiment, which is likely to be attributed to the Bank of England's monetary policy stimulus package. In addition to this, muted prospects for house purchase activity were anticipated by the CML, whilst remortgaging activity is expected to experience growth as low interest rates incentivise borrowers to refinance.
- In August, according to the <u>HMRC</u>, the number of property transactions in the UK totalled 97,660. This was a 0.1% decrease from July 2016 and was 6.1% lower compared to a year earlier. The fall in property transactions comes after two months of increases and is likely to be associated with the stamp duty tax changes earlier in April. It is likely that the majority of these transactions were agreed prior to the EU referendum.

#### Construction

• According to the ISSB, UK steel production totalled 131.5 thousand tonnes per week in August, an annual fall of 37.5% and a 16.0% decrease month-on-month. The annual decline largely reflects steel plant closures by SSI last year amid challenges in the steel industry.

#### Relevant Authorities Workshop #2 - 07 November (London)

Our second workshop on project data management and templates will take place on the 7<sup>th</sup> November from 1.00 - 5.00. Following on from the successful initial meeting, CPA will be hosting further events to ensure all members have the opportunity to engage and take part in the data management initiative. Following the workshop held on 18<sup>th</sup> August, work on developing the LEXiCON system and website has been underway. The software being developed by <u>BRE</u> has undergone several iterations and will soon be ready for testing.

The new sections of the CPA website have been drafted and are being reviewed before handing to the web designers. While the initial standard set out the system and processes a substantial amount of work has been needed to ensure admin processes, governance, protocols and practical information handling, are addressed.

Additionally we have been discussing further collaboration with other bodies in the industry to make sure we have the widest possible support. We are very pleased to note that the <u>UK BIM Task Group</u> are lending their support uniquely to the LEXiCON process. Additionally meetings have been held recently with CPE and the CEN working groups who were both in support of the programme. Establishing this as a European as well as a UK process is very much a reality.

A lot of work has yet to be done and necessarily this falls to a small group of expert volunteers but significant and positive progress is being made. In the mean time we would ask all of those who take part to have a little patience while we get things up and running. We will hope to gradually open up the web site through the Autumn period.

# Recommended Reading: CLC Report on Innovation Workstream -- Roadmapping to improve productivity, capacity and innovation in the housing sector

The Construction Leadership Council's Innovation in buildings workstream, led by Mike Chaldecott from CPA member Saint-Gobain, aims to embed new approaches to all phases of the construction process for buildings, utilising work already in progress such as the Digital Built Britain strategy and Modern Methods of Construction (MMC). The CLC has published a report following a one-day workshop in April. The aim of the workshop was to help develop a strategic roadmap of barriers to take-up and commercialisation of Modern Methods of Construction (MMC), and develop solutions to help increase the percentage of new buildings built using, substantially, MMC. The aim is to

improve productivity, capacity and the use of innovation in the housing sector by removing barriers to progress and helping the industry to move the new methods from development through to actual commercial use and thereby increase housing supply. #### **Apprenticeship Vacancies Survey**

The National Apprenticeship Service (NAS) and the new Digital Apprenticeship Service (DAS) are trying to measure if employers would prefer to post and manage their own apprenticeship job vacancies directly on their <u>Find An Apprenticeship (FAA)</u> free website. The survey below is focused on those employers that have recruited an apprentice before. They are designing the functionality for Find An Apprenticeship, but if employers are happy to leave it to the training provider to post their advert and manage the application(s) then this functionality will not be built. This is in response to some employers requesting this functionality going forward.

The survey is specifically around what NAS can do on the digital service to support recruitment, with a particular emphasis on trying to understand the level of interest employers have in posting vacancies themselves, rather than getting their training provider to do it for them. NAS have been asked for this functionality by employers, but to build it they need to understand how many employers would need it, and what they need it to do. *To view the survey click <u>here</u>*.

#### Indicators for the environmental performance of buildings' - Common EU framework

The European Commission is running a public consultation on the first draft proposals for indicators for the 'development of a common EU framework of indicators for the environmental performance of buildings'. This will close on 7th October. The consultation takes the form of an on-line questionnaire which can be accessed <u>here</u>. The consultation focusses on a first draft set of indicators that has been identified by the Joint Research Centre (JRC) of the European Commission. These proposals are based on the findings from a broad initial scoping of experience in performance improvement and measurement across Europe. ## State of Nature Report issued, Contractors Big Biodiversity Challenge and Nature after Minerals

The latest major report on the status of wildlife and habitats in Britain shows major nature depletion across the UK. The <u>State of Nature</u> <u>report</u> was compiled by 53 wildlife organisations including the RSPB, National Trust and the Wildlife Trusts. Attempting to reverse this trend is the Construction Contractors <u>Big Biodiversity Challenge</u> managed by CIRIA which held its annual awards event this week. This is now well supported by a wide range of contractors both big and small. Within manufacturing, the Mineral Products Association runs a major awards scheme on <u>quarries and biodiversity restoration</u> and the <u>Nature after Minerals programme</u> is a collaborative initiative led by the <u>RSPB</u> and supported by <u>Natural England</u>, the <u>Mineral Products Association</u> and the <u>British Aggregates Association</u>. ## The Assessment of Energy Performance of Non-domestic Buildings (Scotland) Regulations 2016

This came into effect on 1<sup>st</sup> September 2016 and was made in response to Section 63 of the Climate Change (Scotland) Act 2009. It forms part of Scotland's action to reduce greenhouse gas emissions from non-domestic buildings. The regulations apply to the sale or rental (to a new tenant) of non-domestic buildings of more than 1000m<sup>2</sup>. In addition to providing a valid Display Energy Certificate, owners of such buildings are now required to assess their building and produce an action plan covering improvement work to meet the carbon, energy performance and emission targets identified in this plan as part of the sale or rental process. The owners must either undertake this improvement work or they may defer such work by reporting annual operational energy use. Buildings that meet energy standards equivalent to those introduced by the 2002 building regulations are exempt, as are those already improved under the Green Deal. #### Autumn Statement date announced as Wednesday 23 November

The Chancellor of the Exchequer, Philip Hammond, has announced that he will present his first Autumn Statement to Parliament on 23 November 2016. The government has published its guidance on Autumn Statement submissions, which can be viewed <u>here</u>. Submissions should be submitted by Friday 7 October 2016.

#### Business, Innovation and Skills Select Committee: BIS Committee launches inquiry into Government's Industrial Strategy

The Business, Innovation and Skills Committee (BIS) has launched an inquiry into the Government's industrial strategy. The inquiry launch follows the inclusion of the term "industrial strategy" into the Department for Business's name and an indication from the new Prime Minister, Theresa May, that her government will explicitly intervene to support certain parts of the economy. The Committee will consider what the Government means by industrial strategy and questions how interventionist in the free market it should be. It will also look at the industrial strategies of previous governments and of other countries to see if there are any lessons to be learnt.
