State of Trade Survey for 2016 Q3

The State of Trade Survey for 2016 Q3 has been published today. Construction product manufacturers painted a largely positive picture for sales in Q3, which marked a fourteenth consecutive quarter of growth. On the heavy side, a balance of 26% of firms reported an increase in sales during the quarter, down from 52% in Q2. Half of light side firms reported a rise in product sales, up from 38% in the previous quarter. This was the first survey covering the post-referendum period and forward-looking indicators signalled a positive outlook for the next quarter and year ahead.

Economy

- The Markit/CIPS PMI for <u>manufacturing</u> was 55.4 in September, up from 53.4 in August. The latest reading was above the no-change mark of 50, **indicating that manufacturing activity expanded**, **and was the highest since June 2014**. Manufacturers reported that **growth in new orders was driven by the domestic market and higher demand from overseas**, supported by the weaker Sterling exchange rate.
- The Markit/CIPS PMI for <u>construction</u> was 52.3 in September, up from 49.2 in August and above the no-change mark of 50 for the first time in four months, indicating that construction activity expanded. The return to growth was supported by a recovery in residential building, as well as an increase in civil engineering activity reflecting improved sentiment. Commercial construction activity declined for a fourth consecutive month. Looking at the year ahead, construction firms signalled improved optimism regarding the outlook.
- The Markit/CIPS PMI for <u>services</u> was 52.6 in September, down from 52.9 in August. Although the latest reading remained above the no-change mark of 50, which indicates growth, the rate of expansion slowed. Similar to the manufacturing sector, the latest survey reflected new business inflows, particularly from overseas. However, input prices accelerated at the fastest pace in nearly four years due to upward pressure from the weak Sterling exchange rate.
- The price of Brent Crude oil averaged \$46.2 per barrel in September, an increase of 0.1% on a monthly basis but 2.2% lower compared to September 2015, according to the World Bank.
- In September, the Sterling/US Dollar exchange rate averaged 1.31, according to the <u>Bank of England</u>. This was 0.3% higher monthon-month but depreciated 14.3% on an annual basis. Against the Euro, the Sterling averaged 1.17, a 0.3% increase compared to August but 14.2% lower than a year earlier.
- In August, according to the <u>ONS</u>, industrial production decreased 0.4% on a monthly basis but was 0.7% higher compared to a year earlier, reflecting rises in the water supply, sewerage and waste management and manufacturing sectors. Manufacturing output during August increased 0.2% month-on-month and was 0.5% higher year-on-year, **driven by growth in the transport** equipment sector.
- In August, the UK's deficit on trade in goods and services was £4.7 billion, widening from £2.2 billion in July and £3.3 billion in August 2015, according to the <u>ONS</u>. Exports of goods increased 10.6% year-on-year to £25.8 billion, whilst imports increased 13.0% to £37.9 billion, leaving a goods deficit of £12.1 billion.

Housing

According to <u>Halifax</u>, UK house prices increased 5.8% year-on-year in September and were 0.1% higher than in August. However, in Q3, house prices fell 0.1% quarter-on-quarter. The average UK house price in August was £214,024. The latest figures show that annual house price growth has continued moderating since March 2016 amid weakening demand from rising affordability issues.
Looking forward, Halifax expects house price growth to continue, supported by low mortgage rates and a shortage of properties on the market.

Construction

• According to <u>BEIS</u>, the construction material price index for all work increased 1.3% in the year to August and rose 0.7% on a monthly basis. Construction materials prices for new housing, other work and repair and maintenance rose 2.1%, 1.1% and 1.9%, respectively, in the year to August. In the 12 months to August, the materials reporting the largest price increases were imported sawn or planed wood, sanitaryware and fabricated structural steel.

Recommended Reading: CLC Report on Innovation Workstream -- Roadmapping to improve productivity, capacity and innovation in the housing sector

The Construction Leadership Council's Innovation in buildings workstream, led by Mike Chaldecott from CPA member Saint-Gobain, aims to embed new approaches to all phases of the construction process for buildings, utilising work already in progress such as the Digital Built Britain strategy and Modern Methods of Construction (MMC). The CLC has published a report following a one-day workshop in April. The aim of the workshop was to help develop a strategic roadmap of barriers to take-up and commercialisation of Modern Methods of Construction (MMC), and develop solutions to help increase the percentage of new buildings built using, substantially, MMC. The aim is to improve productivity, capacity and the use of innovation in the housing sector by removing barriers to progress and helping the industry to move the new methods from development through to actual commercial use and thereby increase housing supply. The Labour Party has confirmed a number of changes to the shadow cabinet:

- Diane Abbott replaces Andy Burnham as shadow home secretary.
- Baroness Chakrabarti has been appointed as shadow attorney general.
- Nia Griffith replaces Clive Lewis as shadow defence secretary.
- Clive Lewis has been appointed as shadow secretary for business, energy and industrial strategy. He takes over the role from Jon Trickett who remains as shadow Lord President of the Council and Labour's national campaigns co-ordinator.
- Keir Starmer replaces Emily Thornberry as shadow Brexit secretary. Thornberry remains as shadow foreign secretary.
- Jonathan Reynolds has been appointed as shadow economic secretary to the Treasury.
- Sarah Champion replaces Angela Rayner as shadow women and equalities minister. Rayner remains as shadow secretary of state for education.
- Dawn Butler has been appointed as shadow minister for Black and Minority Ethnic communities.
- Jo Stevens replaces Paul Flynn as shadow secretary of state for Wales. Flynn remains as shadow leader of the House of Commons.
- Nick Brown was appointed as chief whip, replacing Rosie Winterton.
