HSE Meeting 2 July 2014 – Notes

Welcome & introductions by David Frise

Robert Parkes – Health and Safety Executive

Role of HSE is as a regulator not an advisor.

Fee for Intervention - FFI

Their job is to deal with possible health and safety issues that are reported by site workers and or members of the public and investigate by various means eg telephone and or site visits to see if a material breach of the Health and Safety at Work Act has taken place and take appropriate action which could be a FFI charge and or prosecution.

1:3 visits currently generate a charge. The clock starts when the inspector declares it has and will run from the time they came on site at a rate of £124 per hour. Time is recorded from timesheets and a detailed breakdown is given with the charge.

Even if the HSE do not proceed with a prosecution or if a prosecution fails the FFI charge could still be levied.

The FFI can be triggered by phone, if for example a photograph of a material breach is sent to the HSE or posted on a social media site.

There is a perception that HSE only goes after the principal contractor and not clients or the designer because it is easy. HSE stated that they do prosecute clients.

Members raised concerns about unrealistic programmes causing an increase in risk. Clients are fully aware that by holding contractors to an unrealistic completion date this will require more labour on site, longer working hours and multiple trades operating simultaneously in the same spaces. Contractors are put under undue pressure to complete, through contracts imposing for example liquidated damages. Perhaps if a client refuses to grant an extension of time they should have to provide an explanation of how the risk will be mitigated.

Additional risks are created when site programmes are compressed and clients need to be advised of the potential H&S risks when multiple trades are working on site simultaneously and over extended working hours.

It's about treating the symptom not the disease. HSE tends to investigate the incident without assessing whether there might be an underlying issue. Perhaps some research into number of accidents occurring late in contract programmes is required?

More needs to be done by HSE to advise and educate clients and their profession

The FFI fees levied are returned to the Treasury and is not classed as income. *To be checked – see action point below.*

There is not a monetary fee target set for FFI.

Does HSE have problems establishing who operatives work for on site with so many LOSCs?

In terms of health and safety HSE do not draw any distinction between LOSC's and PAYE workers and class all workers as employees. There is no focus on LOSC's and no data is collected that differentiates LOSC's and PAYE workers.

HSE should publish a regular what's good and what's bad summary of material breaches they find on construction sites.

Health

More needs to be done to improve the general health of construction workers by reducing the amount of dust generation, controlling asbestos exposure and better manual handling. The main areas that are causing long term illnesses. More needs to be done in the design stages to reduce cutting and forming of materials on site that create dust as well as using more and better equipment that reduces the amount of manual handling.

400 sites will be targeted raising the profile of health. Health is a much greater issue than safety in terms of the number of people it impacts.

Research papers on the benefits of health monitoring are available on the HSE website.

Jim Senior reported that the level of interest in the workforce around health issues had surprised Brookfield Multiplex. They found this very beneficial in raising general awareness of the risks.

Up and Coming Activity

A refurbishment initiative, one month of intense activity aimed at the smaller sites where the highest risk lay. The start date is not yet known.

There will be continuing visits checking asbestos removal contractors.

Asked how the HSE targeted sites;

- Notifications through building control
- Reconnaissance visits
- Looking at trends

HSE has less inspectors than imagined, in East Anglia for example there are 6½ inspectors from King's Lynn to Thurrock, there are 4 teams of 6 in London.

CDM

Hoped all contributed to the consultation process that closed two weeks ago.

The consultation response will be by April 2015 CDM Coordination function to be removed Domestic clients will be included

BIM4FitOut

Nuclear
